# PHASE 1 – BUILDING PAINTING PROJECT

A meeting was held at the Cabana 2 on 11/16/2017 to inform the homeowners of the units in these selected 5 buildings of the results of the inspections, necessary dry-rot repairs, surface preparations and coordination between contractors and homeowners for the paint jobs to be completed in 2017.

#### RESIDENTS ENCOURAGED TO CONTINUE TO ALERT UCPD OF SUSPICIOUS ACTIVITIES IN CONTEMPO

On 10-24-2017, during the meeting with the COPPS unit of UCPD, hosted by Contempo and NWG, residents of Contempo had several good exchanges and received advice from the COPPS unit on how to maintain the low crime rate in the neighborhood. It was a productive meeting in which the COPPS unit complimented Contempo on the progress that we have made over the years and highlighted some of the efforts that the COPPS unit are taking to further reduce issues in our area.

MOST IMPORTANT: Continue to REPORT ANY SUSPICIOUS ACTIVITIES. Your active involvement in reporting suspicious activities has been praised by the UCPD COPPS unit. We encourage you to be AWARE and contact the UCPD if something doesn't look right in your neighborhood! Residents are the first line of defense.

Between October 2016 and October 2017, there were 145 calls made to the UCPD from Contempo. Most of those were for minor issues like noise complaints (including barking dogs). Contempo boasts attractive statistics considering the size and density of our community. Unfortunately, Contempo has experienced a slight increase in property crime (stolen vehicles, package theft, vehicle break ins, burglary, etc) over the past year but this is a common trend seen throughout the tri city area. To combat this, the COPPS unit recommends being vigilant and reporting ANY suspicious activity.

Examples of Suspicious Activity May Include ...

- Suspicious Persons going door to door in residential areas, that seem to be testing doorknobs or if one or more of the subjects goes into a side or backyard.
- Non-resident or unfamiliar subject directly attempting to access the side or backyard of a unit. This is suspicious
  under any circumstance.
- Person(s) carrying property on foot Suspicious at an unusual hour or in an unusual place.
- Suspicious Vehicles travelling particularly slowly or without their lights at night.
- Parked and occupied vehicles vehicles containing one or more individuals, especially significant during unusual hours, or if it appears business transactions are being made from the vehicle.
